3. **Opening Comments**

Co-President Brian Moreno highlights leadership in 'Washington State Leadership Board (WSLB) and encourages members to demonstrate and model leadership in WSLB Practices. As the board experiences change and expects more change, President Moreno encourages Board Members to elevate and raise leadership voices they have the privilege of collaborating with in their daily work.

- a. President Moreno introduces new Directors!
 - Michael Meotti serves as the Executive Director of the Washington Student Achievement Council (WSAC) -- Michael was also recently awarded the 2023 Exceptional Leader Award by The State Higher Education Executive Officers Association (SHEEO) of Portland, OR.
 - Dr. Suzanne Ames serves as the President of Peninsula Community College (PCC).
 - Ex-officio Maria Sigüenza serves as the Executive Director for the WA State Commission on Hispanic Affairs (CHA).

4. Treasurer's Report

The Treasurer's Report was presented by Executive Director of WSLB Audrey Baker, and Guest Paul Bitar Senior Financial Consultant at the Department of Enterprise.

- a. Executive Director Audrey Baker highlights the financial health of WSLB reporting performance in the black.
 - General Operating Fund (26H) as of 05/31/23 the YTD (year-to-date) expenditures for FY 23 total \$519,073.
 - As of 05/31/23, General Operating Fund (26H) has a total balance of \$414,700.72
 - License Plate Revenues (26J) as of 05/31/23 the YTD (year-to-date) revenue for FY 23 total \$129,870.70.
 - WSLB receives roughly \$140k from Licensing partnerships with Seattle Seahawks, Seattle Kraken, Seattle Mariners, Seattle Storm, and Seattle Sounders.
 - As of 05/31/23, WSLB is projected to spend \$637k from General Operating (26H) and an estimated \$23k from License Plate Revenues (26J).
- Executive Director Audrey Baker noted that these numbers do not reflect June 2023 expenditures as the financial team is still working to close out the fiscal year (FY) 23.
- c. As WSLB is still in its infancy, regarding its state agency status, it is expected that allocation adjustments will be made to accurately reflect the agency's spending.
 - Specific allocation adjustments will be made in categories that supersede their FY 23 budget. Examples include but are not limited to Attorney General Office Services, Team S.A.M (Sports and Mentoring) Programming, and Outof-State Air Transportation. Paul Bitar Senior Financial Consultant at the

Department of Enterprise highlights internal practices currently in place to uphold the integrity of WSLB and its application of State Accounting Rules.

 Senior Financial Consultant Bitar does not expect any issues regarding future audits. Due to the unique nature of WSLB functions, Bitar expects WSLB's paper trail will play an integral and pertinent role in the audit process.

5. Guest Speakers

The Board was joined by the Global Services España Team, members include Javi (English Teacher), Javier (History Teacher), and Cesar (Programming Lead) who are visiting us from World Fellows España. The Global Services Team also brought an international student representative who is participating in the Domestic Pilot Program presented.

a. The Ripple

- The Global Services Team introduced and discussed the Domestic Pilot Program. The Domestic Program provides a cultural component domestically. Students will participate in sessions with their counterparts visiting from the World Fellows España program – providing all students the opportunity to be culturally and linguistically immersed.
- España Programming Lead Cesar introduced the impact of the Domestic Pilot Program for both international and domestic participants, benefits include a development of cultural awareness, social engagement, and perspective.
- The student representative was able to share their experience as an international student who has participated in the program for 2 years. The student commented that their English, cultural appreciation, and environmental awareness all improved during their participation.
- b. Q & A and discussion
 - No questions were presented by Board Members. WSLB Executive Director Audrey Baker asked the Global Services Team to highlight some of the demonstrations of leadership displayed by WA World Fellow (WWF) students who have had the privilege of participating in both the Spain and the U.S. WWF programs. Some specific highlights include the development of social interaction, cultural attitudes, and language immersion.

6. Executive Committee Report

The Executive Committee Report was presented by Co-President Brian Moreno.
