Adoption of Agenda and Previous Meeting Minutes

The motion to approve today's agenda and the meeting's minutes from August 9th, 2023, was motioned by Olivia Sarriugarte and seconded by Andrea Ornelas. The motion was carried.

3. Opening Comments

Co-president, Brian Moreno expressed gratitude for the momentum leading into the upcoming inperson Mission, Vision and Goal Setting workshop.

4. Treasurer's Report

Executive Director, Audrey Baker provided a detailed report on the WSLB's financial status, including expenditures, revenue, and upcoming decision packages. The WSLB is in excellent financial condition, with a projected end balance of \$173,000 in the Operating Account and \$329,000 in the License Plate Account. The WSLB has also budgeted for a part-time employee to coordinate and administer the Team S.A.M. and Boundless Washington programs.

In other news, the Board Governance Committee is considering removing the treasurer position as it is deemed redundant. The financial responsibilities are already being executed by the staff's team, and the efforts of the treasurer and finance committee members could be better utilized in other areas.

5. Committee Reports

Executive Committee

Co-President, Brian Moreno reviews the WA Leadership Awards and the exciting conversation regarding the current nominees, as well engaging the board for future nominations in hopes of accurately representing the leadership displayed throughout WA state. Co-President, Brian Moreno presented the board engagement survey results and noted the strong bias to action and interest in tangible outcomes. Presidents' Colin and Brian explain the intentional behind the upcoming Mission, Vision ang Goal setting workshop and highlight that the focus of this workshop will be on broader strategies and that lead into incremental improvement.

WA World Fellows Committee

Co-President and Chair of the WA World Fellow Committee, Colin Pierce shares exciting news about the Washington World Fellows Committee's new program, the Domestic Advocates Program, which is designed for students who may not be able to travel. The program focuses on advocacy and includes post-secondary and college preparation, leadership development, and global exchange. The team spent time researching state statutes to ensure that the program is well within the statutes, and the applications are now open for both the International Ambassadors Program and the Domestic Advocates Program.

Boundless WA/Team SAM Committee

Chair of Boundless WA/Team SAM Andrea Ornelas reports that both the programs have undergone changes, with the Boundless Washington Summer Adventure set to be piloted in Eastern Washington this summer and a part-time program coordinator being recruited to manage both programs. Both program applications are open and Boundless Washington applications close on December 18th and Team SAM applications close on December 31st.

Compassion Scholars Committee

Chair of Compassion Scholars, Olivia Sarriugarte reports that student and mentor applications for next year's cohort have closed! The committee is finalizing their rubrics and hope to announce the newest cohort at the end of this month. After the cohort is selected the committee will be moving onto planning for next year's cohort trip.

• Legislative Affairs Committee

Executive Director, Audrey Baker announces the second annual Day on the Hill event, which will take place in Olympia on February 22nd, 2024. The event is an opportunity for students to educate legislators on their programs and for board members to meet program participants. The event is a wholesome and meaningful experience for students and board members alike. The event falls on the same day as the WA Leadership Awards and the Quarter 1 Board Meeting of year 2024.

Executive Director Baker also shares that Ex-Officio Skyler Rude will be stepping down from the board, and the board will receive a new representative assigned from his

Director Ubungen continues to explain the history and purpose of the leadership pillars, which were created to provide consistent quality programming across all WSLB programs. The pillars were developed based on input from different leaders in various areas and are used to teach leadership traits to students in different programs.

Board Member Involvement in Leadership Curriculum

Programs Coordinator, Claire Muehleisen notes that board members can participate in the leadership curriculum by sharing information and resources through a Google Drive folder. Claire shares an overview of the resources available in the Google Drive folder, including a form to submit relevant documents or links. The board can also contribute to the speaker series and recognize individuals who exemplify the leadership pillars.
